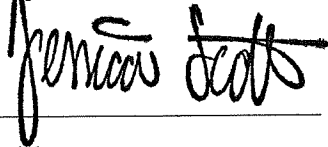

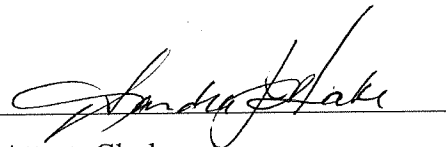
Motion Carried 6-0.
